ADMISSION FOR NON-RESIDENT STUDENTS

STATEMENT OF POLICY

Pursuant to the Patrick County Public Schools Policies and Procedures Manual, students of parents whose legal residence is outside Patrick County may in the discretion of the School Board, be admitted to the public schools of the Division and may, in the discretion of the Board, be charged tuition.

ELIGIBILITY REQUIREMENTS FOR ADMISSION

Notwithstanding compliance with applicable Virginia Laws (preschool physical examination, verification of birth, immunization, and social security number) consideration for admission is also contingent upon a student's academic achievement, behavior, and attendance record.

All non-resident placements are dependent upon sufficient space available in the requested school without hiring additional staff. If a class overload develops due to any reason, non-resident placements may be immediately rescinded.

- Non-resident placements may be withdrawn by the school administration at any time for any reason.
- Parents are responsible for student transportation.
- Placement is subject to availability of teachers and classroom space.

TUITION PROVISION FOR ADMISSION

- No tuition is charged to parents/guardians.

Note: Pursuant to 22.1-3 of the Code of Virginia, the school division will not accept out-of-state students whose parents/guardians give entrustment to a person living within the school division solely for school purposes.
